**It is agreed as follows:**

### **1 Object of this Contract: Agreement for Services**

SL agrees to provide to the Customer and the Customer agrees to pay for Storage Services, and each Party agrees to observe and comply with the Storage Services Contract during the term of the Storage Services Contract.

### **2 Storage Services Contract**

2.1 This Storage Services Contract comprises the following documents:

- (a) this signature document (including any schedule or annex thereto) (**Signature Document**);
- (b) the Specific Terms; and
- (c) the General Terms and Conditions.

2.2 In the event of any discrepancy, inconsistency or conflict arising between the documents forming part of this Storage Services Contract, the order of priority shall be as follows (save where expressly provided to the contrary):

- (a) this signature document (excluding any schedule or annex thereto);
- (b) the schedules and annexes to this signature document;
- (c) the Specific Terms (excluding any schedule or annex thereto);
- (d) the schedules and annexes to the Specific Terms;
- (e) the General Terms and Conditions (excluding any schedule, annex or appendix thereto); and
- (f) the schedules, annexes and appendices to the General Terms and Conditions.

### **3 Miscellaneous**

This Storage Services Contract may be executed in any number of counterparts and by the Parties on separate counterparts. Each counterpart shall constitute an original of this Storage Services Contract, but together the counterparts shall constitute one document
